









Dear friends,

We are at the end of 2014 – 2020 programming period, which has been marked with difficult challenges.

In the past three years, the spending of EU funds has increased by more than 6 billion euros and Slovakia moved in the rank comparing the spending of EU funds from 27th to the 21st place.

It was no coincidence but rather a result of hard work and a series of important measures for better, faster and more transparent spending of EU funds.

Since March 2020, we have introduced, in total, five antibureaucratic packages, including amendment to the Act on the contribution provided from the European structural and investment funds that has led to a significant simplification for applicants, beneficiaries as well as providers.

The government has also introduced a new system for the crisis management of EU funds in order to prevent losing any money from the European package for Slovakia.

We managed to invest the funds allocated for 2014 – 2020 programming period to thousands of projects that have contributed and are still helping to improve lives of people in regions – because this is what they are intended for.

In the programming period, money was spent
by means of six main operational programmes:
Human Resources, Integrated Infrastructure,
Quality of the Environment, Integrated Regional
Operational Programme, Effective Public
Administration and Technical Assistance. European
money was also used to finance projects by
means of Cross-Border Operational Programmes,

Rural Development Programme and Fisheries

Operational Programme.

The brochure you are now holding in your hands provides an overview of results that we managed to accomplish and, thus, help people in regions in Slovakia thanks to investments from EU funds allocated for 2014 – 2020 programming period. Here, you can learn what particular projects have been implemented or supported in the field of education, social services, transport, environment protection and sustainability, research, development and innovation or technologies in enterprises.

The programming period that is about to end soon has been marked with two events that dramatically affected lives of people and rewrote reality of the European society from the preceding decades – relatively peaceful reality without pandemics and wars. Everything changed with the onset of the COVID-19 pandemic on the verge of 2019/2020 and, later, with an unprecedented attack of Russia at Ukraine in February 2022. Slovakia and Europe found themselves in the middle of a joint battle for preserving lives and basic values of our society. These events will have an impact on the development of the society also

in the future — even now, we are witnessing a surging rise of prices of construction materials and energies as well as other commodities.

The European Union responded to both these challenges and prepared legislative adaptations that enabled spending EU resources and transferring them in order to solve problems brought about by the pandemic and, later, the war in Ukraine. It also allocated additional funds for European countries in the form of the REACT-EU package. Also that money helped inhabitants in the EU – and in Slovakia – to better face unexpected challenges.

We are standing at the doorstep of the new programming period that is already prepared and represents a substantial revolution in spending of EU funds. It is also because it combines six main operational programmes into one, with uniform rules, which will bring even more transparency, efficiency and less bureaucracy. The past programming period has shown us that we must be prepared, at any moment, to face new challenges, even the least probable ones. We want the new EU funds to also meet their goal and get exactly where they are supposed to be delivered — to help people.



The programme's activities place a strong emphasis on nature conservation and improving the quality of the environment.

In the 2014 – 2020 programming period, ESIF in Slovakia contribute to support the transition to a low-carbon economy by more than EUR 1 billion.

Climate change affiliated with unusual weather conditions, which make the regions of Slovakia impacted by droughts, forest fires, tidal rains and floods, creates a situation that requires a complex of preventive measures. In the 2014 – 2020 programming period, ESIF in Slovakia contribute by nearly EUR 0.9 billion to support climate change adaptation.

Examples of supported investments

All components of the environment compose a unique resource that needs to be protected and used sustainably. This creates the preconditions for our long-term survival and cooperation with the environment we depend on. ESIF in Slovakia contribute almost EUR 2.2 billion to this priority area in the 2014 – 2020 programming period.

Promoting sustainable transport







Development of railway transport at Trans-European Transport Network (TEN – T) corridors



The ESIF resources for transport development in the 2014 – 2020 programming period account for EUR 3.7 billion. This is almost one quarter of the total ESIF resources available in Slovakia.

Examples of supported investments

- modernization of railway tracks, renovation of train sets and locomotives
- build-up of expressways and regional roads
- modernization in the municipal public transport – new vehicles, routes, junctions, catchment parking lots

- cycle paths and cycle routes
- modernization of lock chambers, measures to improve a smooth and safe operation of the Danube waterway

- the project included build-up of 2 tunnels, 14 new railway bridges, 4 passenger subway crossings and reconstruction of railway stations and stops along the track with the emphasis on barrier-free access





CYCLING PATH MALÉ LEVÁRE – VEĽKÉ LEVÁRE

Development of cycling transport in municipalities

- a new cycling path with the length of 3.3 km connects the railway station and bus stops between villages with the focus on safety of its users
- the cycling path also includes marked crossings for bikers and a sheltered bicycle parking at the railway station

- the newly built cycling path also connects to local cycling paths that even increases attractiveness of cycling transport in the region

Examples of supported investments

For the 2014 – 2020 programming period, there is EUR 1.4 billion allocated from the ESIF for the social inclusion, poverty reduction and anti-discrimination related issues. Regarding the social inclusion of people from marginalized Roma communities, the ESIF resources are fundamental, if not the only, source of funding.



Beneficiary: Žena v tiesni, o. z.

- the purpose of the project was to provide comprehensive assistance and support to women experiencing violence in family relation and to the children by means of specialised consultancy, crisis intervention, legal assistance and safe space
- the beneficiary of the project is civil association "Žena v tiesni/Woman in need/", which has been operating in the Turiec area as an accredited entity for 15 years already
- during three years, the assistance in the form of out-patient consultancy, crisis line and on-line advisory service was provided to 303 women in the Turiec area in the Žilina Region
- the project also included the build-up of a consultancy room and a kids corner

- Decreasing the number of people at risk of poverty. The number of people at the risk of poverty was reduced by 255,000 and number of households receiving social assistance benefit (in material and social deprivation) was reduced by 55 %3
- Improving the quality of social services provision
- Improving the situation of marginalised Roma communities



- ✓ To adopt systematic measures in the field of education, housing or attitudes of the majority population towards minorities in order to reduce the level of social exclusion
- ✓ To mitigate the critical situation of the specific groups, i.e. people from the marginalized Roma communities, people with disabilities, lonely parents or the significant group of seniors
- To improve an accessibility of community-based services, including the care services of elderly and disable people provided directly at the client's home

Quality education and educated workforce rank to basic pillars of economic and employment growth, and life quality of inhabitants. In the 2014 – 2020 programming period, there are EUR 634 million from the ESIF allocated in this area of support in Slovakia.

- the purpose of the project was to develop an effective model of education and preparation of young people for jobs in the field of informatics and information technologies
- the project supported building partnerships between schools and companies in IT sector
- the project was joined by 313 primary schools and 251 secondary schools in Slovakia, outside of the Bratislava Region
- the project resulted in enhancement of qualification of 3,783 pedagogical employees and experts; 38 partnerships connecting universities and the business sector; 1,123 innovative methodologies for development of scholastic skills of primary and secondary school pupils and new textbooks for students of IT study programmes



The ESIF in this field support:

- Development of dual education programmes
- Starting implementation of the life-long learning of adults in areas of digital, financial, entrepreneurial and citizen literacy
- Increasing numbers of population with tertiary education in Slovakia. Some 40 % of population aged 30-34 years may achieve tertiary education by 20204

An important national strategic goal is a modern, professional, efficient, reliable, non-corrupted and transparent public administration by 2020 in Slovakia. The ESIF resources allocate EUR 261 million in this area in the 2014 – 2020 programming period.

- the purpose of the project was to build preconditions, test and introduce measures for participative development of public policies at local, regional and national level
- the project put together experts from the public administration sector, NGOs, academia, civil and private sector in 12 pilot projects in developing particular public policies
- >> project outputs comprise more than 70 expert analyses, methodologies, manuals and publications, 5 legislative proposals, 145 information events for more than 4,000 participants
- the project also included establishment of a new book edition "Participation" and a new educational programme was prepared and tested for employees in the public administration and representatives of NGOs

SLOVAKIA IS ACTIVE IN TACKLING NEW CHALLENGES THROUGH EUROPEAN **COMMISSION INITIATIVES**



01. Implementation of measures to combat the COVID-19 pandemic:



European Commission has prepared two legislative packages (CRII, CRII+) which have brought flexibilities in the use of the ESIF. Following this, in April 2020, the Slovak Government approved "Proposal for measures financed from the operational programmes of the ESIF to combat the COVID-19 coronavirus pandemic and to eliminate and mitigate its consequences" and reallocated **EUR 1.1 billion** of uncommitted ESIF funds.

The objective of these measures is to support

- maintaining employment: EUR 410.2 million (OP HR),
- ✓ health system: EUR 204.3 million (IROP, OP II),
- for SMEs: EUR 330.2 million (OP II),

- Integrated Rescue System components:
 - EUR 51 million (OP EQ),
- and other measures to mitigate the impact of COVID-19: EUR 109.3 million (OP HR).

02. Implementation of measures to eliminate the impact of pandemic COVID-19 (REACT-EU):



For the 2021 – 2022 period, European Commission has earmarked additional funding for Member States through the new support area No. 13. Slovakia has been allocated EUR 745 million to implement additional measures through the OP HR, IROP, OP EPA and OP FEAD⁵

The aim of these measures is to support

- job retention,
- provision of social services to citizens,
- resilience of the health system,
- distance learning in schools,
- funding for green activities (cycle paths),

- thermal insulation of housing,
- ✓ increasing the capacity of primary schools and the level of vocational education.
- ✓ financial support for health workers, police officers and firefighters,
- provision of food parcels for the most deprived persons.

03. Implementation of measures to support refugees from Ukraine:

In April 2022, the European Commission approved the Cohesion Action Plan for Supporting Refugees from Ukraine in Europe (CARE), which will allow Slovakia to redirect more than EUR 300 million from the 2014 – 2020 programming period to finance e.g., temporary accommodation, food supplies, health care and psychological support for refugees from Ukraine.

04. Implementation of measures for handling of the energy crisis

The purpose of SAFE is to mitigate impacts of the ongoing energy crisis on vulnerable households and small and medium enterprises using the remaining funds from the 2014 – 2020 programming period.

In the sense of the SAFE initiative, it is possible to allocate maximum of EUR 1.45 billion in the Slovak Republic for the assistance with increased energy prices, which can be used to cover expenses incurred in the period from 1 February 2022 until 31 December 2023.
